1 APOLOGIES

2 DECLARATIONS OF INTEREST

3 MINUTES OF MEETING HELD ON 14 FEBRUARY 2023

The minutes of the meeting held on 14 February 2023 were agreed by those present and signed by the Chairman.

4 MATTERS ARISING

4.1 Grit Bin: Berry Close

Cllr JS reported that Ewelme has installed a grit bin in Berry Close and she had spoken to Andrew Robson to thank him.

7 PLANNING

7.1 Planning applications

23/00556/COUAR | Determination as to whether prior approval is required in respect of transport & highway impact, noise, contamination risk, flooding and locational considerations for the conversion of an agricultural building into one dwellinghouse (Class Q(a)) and in relation to design and external appearance of the building (Class Q(b) | Gubbins Hole Farm Edgcott Road Marsh Gibbon Buckinghamshire OX27 OAN It was agreed that a decision on this is outside the remit of the Parish Council.

Action: Clerk to inform Bucks Council that this is a decision that should be made by the Planning Department.

23/00583/APP | Dropped kerb onto Whales Lane to provide access to 2no. parking spaces with turning area to 1 Westbury Terrace | 1 Westbury Terrace Whales Lane Marsh Gibbon Buckinghamshire OX27 0HD Following a lengthy discussion covering:

- Pedestrian safety
- Visibility splay
- Ecology
- Bucks Highways assumption that the traffic is travelling at 20mph when the speed limit is 30mph
- No turning point shown on the plans Councillors agreed to object to the planning application.

Action: Cllr TR to draft a response to Bucks Council, AVDC Area Planning

7.2 Hedge Issues in Whales Lane

Residents present expressed their concern that it appeared that the hedge in Whales Lane was being destroyed and that it should not have been cut during the bird nesting season. However, there was some confusion regarding the dates between 'cutting' a hedge and 'laying' a hedge. It was noted that the hedge had been laid within the allowable time periods and the husbandry of the hedge is up to the landowner as long as he acts within the legal framework, which was followed in this instance.

Chair read a resumé of a telephone conversation Clerk had had with the landowner prior to the meeting:

- He has laid hedge of about 60m around the bend and there was more dead bits in it than originally thought so he will be planting Quick Thorn in the gaps.
- He spoke to the Enforcement Officer about a month ago to inform him what he was going to do.
- Following a call from someone this morning, Enforcement Officer spoke to him at about 11am.
- No plans for housing.
- Grand father took on the hedge and since 1883 his family have been maintaining it.
- Don't require planning permission to lay a hedge even if it is in a conservation area.
- He plans to plant 5 apple trees adjacent to Westbury Terrace.
- Marsh Gibbon is dear to his heart and he will do nothing to desecrate anything.
- Said if we have any questions to call him.

It also was noted that the Parish Council had previously written to the landowner to ask him to cut back the hedge as it was encroaching the road with the possibility of scratching vehicles as they passed.

7.3 Late Notifications

7.4 **Ewelme Sites** – to receive updates on Sites A and B

7.4.1 Site A

It was noted that some marketing material appears to include the open space area within the garden of the show home.

7.4.3 Solar Farm

Cllr JS reported that she had been informed that there are no plans for a solar farm to be built on prime farming land in the village.

8 VALE OF AYLESBURY LOCAL PLAN (VALP)/MARSH GIBBON NEIGHBOURHOOD PLAN (NP)

8.1 Residents asked:

- What the plans are for updating the Neighbourhood Plan. It was explained that there are currently no plans to update the NP and that it is kept on the agenda should there be any requirements to do so.
- What was the point of the Land & Partners presentation. Councillors explained that the presentation
 was held at the request of Land & Partners and that Land & Partners had not informed the Parish
 Council that they would be bringing representatives from Arco. No further contact from Land &
 Partners has been made.

It was suggested by a resident that it would be worth reminding the village that the Neighbourhood Plan exists.

Action: Cllr NL to put a note on Facebook.

9 KING'S CORONATION

The resident present reported that her ideas for the King's Coronation were to have a Scarecrow trail and for residents to organise their own street party. Some funding may be available from the Community Board. She also noted that she has produced a bi-annual magazine and has advertised the event in it. It was agreed to discuss at the next meeting whether or not to make a donation towards the running costs of the magazine.

10 RECREATION GROUND

10.1 Flooding

Chair of the Sports & Social Club gave an update on the recent flooding at the recreation ground club house which was now in the hands of the insurance company.

10.2 Maintenance Equipment

Chair of the Sports & Social Club reported that the club needed to replace its gang mowers and had a fund of approximately £8-10K)towards the costs, however he did not have an exact figure for a replacement.

Chair confirmed that S106 funds could be put towards mowing equipment. Action: Clerk to investigate whether VAT can be reclaimed on the purchase of a new mower.

9.30 remaining residents left the meeting.

11 CLERK'S REPORT 11.1 Finance Report

11.1 Finance Report

Clerk presented the Financial Report for March 2023. Payments totalling £1,619.64 were approved, as detailed in appendix 2. It was agreed that, at the next Finance Meeting, a recommendation will be made on the amount of money to be transferred to the Earmarked Reserve Account.

11.2 **S106**

Cllr NL reported that he had received some more quotes for playground equipment to be funded from S106. It was agreed that eventually, a circular would be issued to residents inviting their comments on what playground equipment should be installed.

11.3 Skateboarding

Currently there is no funding for the skateboarding in the Financial Year 2023-24. Cllr NL reported that the Rothschild Foundation had turned down his claim and he had been advised that the Community Board would be unlikely to make any funding.

Action: Cllr NL to investigate what funding might be available, to advise the organiser and to put a note on Facebook that funding is not available for FY 2023-24.

12 VALE OF AYLESBURY LOCAL PLAN (VALP)/MARSH GIBBON NEIGHBOURHOOD PLAN (NP) See 8.1 above.

12.1 Settlement Review

Clerk had submitted the completed Settlement Review questionnaire to Bucks Council.

12.2 Local Plan for Buckinghamshire – Infrastructure Baseline

A questionnaire for the Local Plan for Buckinghamshire had been received. Action: Cllr ET and Clerk to draft a response.

13 VILLAGE HALL

13.1 Report

Cllr RT noted that a new flagpole had been erected.

King's Coronation

The village hall had contacted the Parish Council asking what plan it had in hand for the King's Coronation. Action: Clerk to respond informing the village hall that a resident has some plans in hand and that the Parish Council is not a 'Social' Committee.

14 PLAY EQUIPMENT, TEENAGE RECREATION AREA AND RECREATION GROUND

14.1 Maintenance

- The following were noted:
 - The zip wire is having a full inspection
 - Gates in the 5-a-side area do not close properly.

15 DEVOLVED SERVICES

The following were noted for FY 2023-24:

- Clerk has returned the signed Devolution Agreement amendment.
- RTM have been confirmed as the grass cutting contractor.

16 ROADS AND PATHWAYS

16.1 **Potholes / Road repairs**

Clerk had reported Pot Holes in West Edge which Bucks Council had repaired.

16.2 Parking in Castle Street

It was noted that cars are exiting dangerously from Berry Close and that a Give Way sign needs to be installed. The final report from Bucks Council still has not been received. **Action: Cllr NL to chase Bucks Council for the report.**

16.3 Road Gritting

A request for gritting the school bus route had been received and advice from Bucks Council sought on how to achieve this. The response from Bucks Council is at **Attachment 3.**

17 STREET LIGHTING

17.1 Maintenance

Faulty street lights were reported in Swan Lane and Millfield Close. The tree surrounding the light in Tompkins Lane has been cut back to enable E.on to make the repair to the light. **Action: Clerk to report to E.on**.

Clerk to check with contractor requirement for carrying out the six yearly checks according to BS7671.

18 CEMETERY MATTERS

18.1 General Maintenance

There were no updates to report.

18.2 Burial, Interments, Advance booking requests and Memorial applications

18.2.1 Burials

Cllr PE reported that there were some trip hazards on the roadway which needed to be resolved. It was agreed that the contractors who did the village hall car park work should be approached for advice. Action: Cllrs PE and ET to request site meeting with the contactor.

19.1 Ware Pond

It was noted that the Horticultural Society had tidied up the area around Ware Pond following the clean out. Actions: Clerk to send thank you to Peter Ferens.

19.2 Flooding

It was thought that the pipe under the road from the pond is blocked. It was agreed that when the water level was low enough an inspection of the pipe would be made.

Action: Clerk to contact Bucks Council Local Area Technician (LAT) for further advice on the flooding by Ware Pond and to carry out the jet work, as promised by the previous LAT, outside the school.

Dear Carole

Please find some information below on gritting and the methodology for the roads that have currently been gritted.

In 2003 there were 35 gritters placed across the County for the gritting of the Highway Network. Buckinghamshire Council required efficiency savings and as a result, reduced the number of vehicles from 35 to 29. To enable us to manage this the number of routes and the total linear KM had to be reduced. To assist in this decision-making process the Risk Matrix was introduced by Winter Maintenance Manager in position at that time. This process was repeated in 2006 which resulted in a further reduction in our gritting fleet from 29 to 25 and subsequently a further reduction in the number of roads on the primary gritting routes.

The risk matrix is a methodology we used to assist us in scoring all of the networks and assess which roads at that time, which were previously salted, would no longer form part of the Precautionary salting network and would instead be placed on the Secondary Routes which are cleared during periods of prolonged snowfall.

The risk matrix consists of several scoring points as indicated below with information gained through various means, these are:

Traffic Flow Data, this information is supplied by the Traffic Information Team which carries out several different ways to count traffic, these are manned junctions with several people counting vehicles over eight hours. Loops in the carriageway which information is set through electrically, or by Truvelo Strips which also count vehicles. Each year we request an update from them to keep our records current. Not all roads are counted every year.

There are two scores with this data - up to 750 vehicles within eight hours scores 0 and 751-3000 scores 10 points.

Gradients (slope/ decent) have three scoring points - up to 1 in 12 scores 0 points, 1 in 12 to 1 in 10 scores 4 points, 1 in 10 and above scores 10 points, these normally have signs which are DFT approved warning signs for steep hills (Slope/ Decent) placed denoting the gradient.

Bends again have three scoring point ranges outside of 30 MPH limits these are classed by degrees of bend up to 5% scores 0, 5 - 10 % scores 4, 10 - 20% scores 10 points, again these are where DFT approved bend warning signs are placed for the single or double bend.

Community Link Road, This is used to ensure a village that has a shopping and/ or Heath Centre is accessible and scores 5 points.

Public Bus, We receive data from the Passenger Transport Department every year to ensure we correctly score a road that is used by public buses and scores 15 points.

School Bus, As above this data is provided by the Passenger Transport Department every year for information on school bus routes and will score 15 points.

Adjacent Key Facilities, This is classified as access to Emergency services/stations for the Fire brigade, Ambulance, Police, Hospitals, and major Power Stations. And scores 10 points.

Previously Salted, as previously stated when this risk matrix was first introduced was a key factor when routes were being removed/ routes reduced however after three years this is no longer counted. It scored 5 points in the initial assessment.

Collision Record, This information is provided to us by the Safety Team working with Thames Valley Police. All reported incidents reported by TV Police are notified to the Safety Team. They review all of these incidents and inform other teams of any Highway related safety issues to try and improve and reduce incidents within the Highway. This information is used to highlight possible additions to the precautionary salting network which carries a score of 5 points.

Efficiency and Practicality, This information is used to ensure routes are efficient and practical to do. All routes are designed with a view that gritters do not drive on any road which is not salted. This includes vehicles gritting these roads are not required to reverse in adverse weather conditions which may lead to an incident. Taking into account road designs, weight limits, Parking restrictions, and Traffic calming. This is scored in a positive or negative weighting.

Hopefully, this explanation of our methodology/ weighting in using the risk matrix gives you a better understanding of our approach regarding requests for additional roads to be included on the primary gritting routes.
