7. **PLANNING**

7.1 New Applications

18/04459/COUAR: 'Proposed change of use (Class Qa) and necessary building operations (Class Qb) for the conversion of two agricultural buildings to form 3 smaller dwellinghouses and 2 larger dwellinghouses' at Charndon Grounds Farm, Twyford To Marsh Gibbon Road, OX27 0AU.
